NARRATIVE REPORT ON COMMUNITY BASED CASES

July-September, 2014

This quarter was full of challenges as the Community-Based Social Workers were faced with various tasks to fulfil not only in terms of their regular functions on case management but also on disaster operation as Typhoon Glenda struck the region. Nevertheless, despite of the numerous tasks they have to carry, a total of 203 clients were served with MTA as the highest number of clients assisted.

Community Based Services:

On Case Management

- Facilitated and acted on referrals requested by Central Office, other regions and other agencies.
- Conducted visit to minor in jails (municipal, district & provincial jails).
- Conducted home visit and assessment to applicants for adoption and foster care.
- Referred clients to LGUs for further intervention and management of cases.
- Conducted case conference with LGU Social Workers on cases needing immediate assistance and further intervention.
- Lobbied with the LGUs regarding adoption/localization of national laws to support sectoral concerns such as women, children and family.
- Attended to clients inquiring on MTA
- Attended/assessed walk-in and referred clients for E-AICS.
- Attended court hearings on CSA and adoption cases.
- Conducted Alternative Parental Care Forum on adoption and foster care in the following municipalities:
 1. Pioduran, Albay
 2. Camalig, Albay
- Provided technical assistance to LGU Social Workers on management of cases such as CSA, neglected, CICL and adoption cases particularly on RA 9523 process.
- Conducted CISD to Teachers and Cluster principal of Gimagtocon Elementary School in Lagonoy, Camarines Sur in response relative to a shooting incident that occurred in the school's premises.

- Coordinated with the LGUs both at the barangay and municipal level regarding submission of disaster report, terminal report and rehabilitation plan relative to Typhoon Glenda.


