The Department of Social Welfare and Development Field Office V, through the GAA, the General Appropriations Act CY 2021 intends to apply the sum of Two Million Eight Hundred Thousand (Php 2,800,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Labor and Materials for Various Repairs and Improvement Works at RSCC/IB GOP 2021-DSWD-008

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Social Welfare and Development Field Office V now invites bids for the above Procurement Project. Completion of the Works is required within 240 working days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Interested bidders may obtain further information from Department of Social Welfare and Development Field Office V and inspect the Bidding Documents at the address given below from 8:00AM to 4:00PM (Except Saturdays, Sundays & Holidays).

4. A complete set of Bidding Documents may be acquired by interested bidders on May 5, 2021 from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php. 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting it in person, or sending it through email.

5. The Department of Social Welfare and Development Field Office V will hold a Pre-Bid Conference on May 12, 2021, 1:00 PM through video conferencing via Google Meet, which shall be open to prospective bidders.

6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, on or before 1:00 PM, May 25, 2021. Late bids shall not be accepted. Late bids shall not be accepted.

7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

8. Bid opening shall be on May 25, 2021, 1:00 PM via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
