The Department of Social Welfare and Development Field Office V, through the General Appropriations Act (GAA) CY 2021 intends to apply the sum of One Million Five Hundred Sixty-six Thousand Pesos (Php. 1,566,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for IB GOP 2021-DSWD-023. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Social Welfare and Development Field Office V now invites bids for the above Procurement Project. Completion of the Works is required 120 working days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Department of Social Welfare and Development Field Office V and inspect the Bidding Documents at the address given below during 8:00AM to 4:00PM (Except Saturdays, Sundays and Holidays).

5. A complete set of Bidding Documents may be acquired by interested bidders on September 9, 2021 from given address and website below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php. 5, 000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting it in person, or sending it through email.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the

Bidding Documents not later than the submission of their bids.

6. The Department of Social Welfare and Development Field Office V will hold a Pre-Bid Conference on September 17, 2:00 PM through videoconferencing/webcasting via Google Meet which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before September 29, 2021, 12:00 PM. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on September 29, 2021, 2:00 PM at the given address below through videoconferencing/webcasting via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. Meeting links will be available upon request through the official BAC Secretariat email address below.

11. The Department of Social Welfare and Development Field Office V reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
