INVITATION FOR NEGOTIATED PROCUREMENT-TWO FAILED BIDDINGS

PROJECT: Supply and Delivery of ICT Equipment and Supplies

ABC: Php 2,484,435.00

- In view of the two (2) failed public biddings conducted, the Department of Social Welfare and Development, Field Office V, intends to negotiate, as authorized by its Regional Director, per BAC Resolution No. 2021-12-043 dated December 13, 2021 in accordance with Section 53.1 Two Failed Biddings of the Revised IRR of RA 9184 the total sum of Two Million Four Hundred Eighty-Four Thousand Four Hundred Thirty Five Pesos (P 2,484,435.00) being the Approved Budget for the Contract (ABC) per IB No. GOP 2021-DSWD-068. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Social Welfare and Development, Field Office V now invites offers/proposals for the said project. Delivery of the Goods is required per approved final schedule. Bidders should submit **updated and valid Platinum PhilGeps Registration**. Also, Bidders should have completed, **within two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. Both documents to be submitted together with the accomplished **Request for Quotation (RFQ)**.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. A Request for Quotation/canvass may be acquired by interested Bidders starting *December* 22, 2021 from the address below. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.
- 5. Pre- Negotiation Conference will be conducted via Google Meet Videoconference on **December 23, 2021 2:00 PM.** Google Meet Link will be emailed to the bidders a day before the activity.

- 6. Offers/Proposal must be duly received by the BAC Secretariat at the address below on or before **12:00 P.M., December 27, 2021**.
- Opening of offers/proposals shall be on December 27, 2021, 2:00 P.M. at DSWD FO
 V. Late bids shall not be accepted.
- 8. As condition for award, Department of Social Welfare and Development, FO V will require an Omnibus Sworn Statement, Performance Security and the latest Business Tax Returns.
- 9. The **Department of Social Welfare and Development, FO V** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
