CONTRACT AGREEMENT

THIS AGREEMENT made this MAY 23 2022 between
DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE V of
the Philippines (hereinafter called "the Entity") of the one part and **LIBERTAD**
CONSUMERS CORPORATION of Ziga Avenue San Juan Tabaco City (hereinafter
called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services,

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:



- Lot 5- Two Million Three Hundred Sixty-Four Thousand Six Hundred Pesos Only (₱ 2,364,600.00)**
