CONTRACT AGREEMENT

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as the</u> <u>Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form</u> <u>part of the Contract.</u>

In consideration for the sum of FOUR MILLION EIGHT HUNDRED FIFTY ONE THOUSAND NINE HUNDRED PESOS AND NO CENTAVOS (P4,851,900.00) or such other sums as may be ascertained, JONECO TECH MARKETING CORP., agrees to provide, Procurement of ICT Equipment for DSWD FOV-AICS (Lot 2 & 4), in accordance with his/her/its Bid;

4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE V** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
