**CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_ day of JAN 06 2021 between  
**DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE V** of  
the Philippines (hereinafter called "the Entity") of the one part and **UNICO TRADING**

of **TWO MILLION ONE HUNDRED EIGHTY-SIX THOUSAND TWO HUNDRED  
FIFTY PESOS (P 2,186,250.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings  
as are respectively assigned to them in the Conditions of Contract  
referred to.
2. The following documents as required by the 2016 revised Implementing  
Rules and Regulations of Republic Act No. 9184 shall be deemed to  
form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements,  
Technical and Financial Proposals, and all other documents or  
statements submitted;

Bid form, including all the documents/statements contained in the  
Bidder's bidding envelopes, as annexes, and all other documents  
submitted (e.g., Bidder's response to request for clarifications on  
the bid), including corrections to the bid, if any, resulting from the  
Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto;  
and
- v. Other contract documents that may be required by existing laws


