A RESOLUTION RECOMMENDING TO THE REGIONAL DIRECTOR TO AWARD VOICE & DATA SUBSCRIPTION FOR INMARSAT DISASTER EMERGENCY COMMUNICATION EQUIPMENT PER IB GOP 2020-DSWD-18 TO IONE RESOURCES, INC. BEING THE SINGLE CALCULATED AND RESPONSIVE BIDDER

WHEREAS, the Disaster Risk Reduction Management Division requested for the VOICE & DATA SUBSCRIPTION FOR INMARSAT DISASTER EMERGENCY COMMUNICATION EQUIPMEN under Purchase Request No. NF 2007-0247 with an Approved Budget Ceiling amounting to P2,742,350.00. Given the amount, said procurement opportunity was posted on PhilGEPS per IB GOP 2020-DSWD-18; on the department's website and on a conspicuous place within the agency for wider dissemination;

WHEREAS, the above-mentioned request is included in the Annual Procurement Plan of the Agency for CY 2020;

WHEREAS, during the scheduled pre-bid conference on September 21, 2020, 9:00 AM, only iONe Resources, Inc. participated. On said activity, the checklist of requirements was discussed one by one. There were clarifications in some requirements, hence a bid bulletin was published on September 23, 2020 for information and guidance of everyone concerned;

WHEREAS, during the deadline for the submission of bids/opening of bids on October 05, 2020, only one (1) bidder submitted bid proposal. Opening, examination of bids and determination of responsiveness were done using a non-discretionary "pass/fail" criterion having the hereunder result:

WHEREAS, post-qualification was conducted by the BAC/Technical Working Group to <u>iOne Resources Inc.</u>, being the sole eligible bidder. Per report submitted by the BAC/TWG the said <u>bidder</u> was found responsive as the technical documents that they have submitted such as PhilGEPS registration, Bid Security and Omnibus Sworn Statement are lawful and valid based on the effectivity date of each document. The required amount of transactions for completed contracts were complied and surpassed. The Single Largest Completed Contract that they have presented was with the **Office of Civil Defense** for the Supply and Delivery of Very Small Aperture Terminal (VSAT) – Auto-Acquire Fly Away Antenna System amounting to P 11,938,682.11. Copies of Official Reciept, Certificate of Completion, Inspection and Acceptance / IAR were presented upon inspection. It was also noted that the said bidder has a Master Supply Agreement with Inmarsat duly signed by Alison Horrous, Director of Inmarsat and Alberto A. Catangui, President of iOne Resources, Inc., dated CY 2018, as proof of partnership with Inmarsat.

WHEREAS, with the foregoing and after due deliberation, the Bids and Awards Committee resolved to declare the bid of iOne Resources Inc. as a responsive bid;

WHEREAS, iOne Resources Inc. submitted bid security in the form of a Bid Securing Declaration notarized by Atty. James K. Abugan last October 1, 2020;

WHEREAS, the funds availability has been certified by the Budget Section on October 22, 2020;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee RESOLVES, as it is hereby RESOLVED:

- a) To declare iONe Resources, Inc. as the <u>Single Calculated and Responsive Bidder</u> for VOICE & DATA SUBSCRIPTION FOR INMARSAT DISASTER EMERGENCY COMMUNICATION EQUIPMENT PER IB GOP 2020-DSWD-18;
- b) To recommend the Award of the Contract to iONe Resources, Inc. in the amount of <u>Two Million Seven Hundred Forty-Two Thousand Three Hundred Twenty Pesos and twenty centavos (Php. 2,742,320.20).</u>
