CONTRACT AGREEMENT

THIS AGREEMENT made the _____ day of DEC 28 2020 between **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE V** of the Philippines (hereinafter called "the Entity") of the one part and **PHILIPPINE NUTRIFOODS CORPORATION** of Alabang, Muntinlupa City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY OF NUTRIPACKS FOR THE SFP 10TH CYCLE IMPLEMENTATION IN BICOL REGION** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIFTY-FOUR MILLION SIX HUNDRED NINETY-SIX THOUSAND TWO HUNDRED FORTY PESOS (P 54,696,240.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:



A RESOLUTION RECOMMENDING TO THE REGIONAL DIRECTOR TO AWARD SUPPLY AND DELIVERY OF NUTRIPACKS FOR THE SFP 10TH CYCLE IMPLEMENTATION IN BICOL REGION PER IB GOP 2020-DSWD-45 TO PHILIPPINE NUTRIFOODS CORPORATION BEING THE SOLE ELIGIBLE BIDDER

WHEREAS, the SFP-PSD requested for the SUPPLY AND DELIVERY OF NUTRIPACKS FOR THE SFP 10TH CYCLE IMPLEMENTATION IN BICOL REGION under Purchase Request No. **NF 2010-0413** with an Approved Budget Ceiling amounting to **P 54,696,240.00**. Given the amount, said procurement opportunity was posted on PhilGEPS per IB GOP 2020-DSWD-45; on the department's website and on a conspicuous place within the agency for wider dissemination;

WHEREAS, the above-mentioned request is included in the Annual Procurement Plan of the Agency for CY 2020;

WHEREAS, during the scheduled Pre-Bid Conference last **November 18, 2020, 1:00 PM**, Philippine Nutrifooods Corporation and HLYC Trading were present;

WHEREAS, during the Pre-Bid Conference, the checklist of requirements was discussed one by one. There were clarifications in some requirements, hence **bid bulletins** were published on **November 21, 2020** for information and guidance of everyone concerned;

WHEREAS, during the deadline for the submission of bids/opening of bids on **December 02, 2020**, only Philippine Nutrifooods Corporation submitted bid proposal. Opening, examination of bids and determination of responsiveness were done using a non-discretionary "pass/fail" criterion having the hereunder result:

WHEREAS, post-qualification was conducted on December 14-15, 2020 by the BAC Members to **Philippine Nutrifooods Corporation** being the Sole Eligible Bidder. Per report submitted by the BAC the said bidder was found responsive as the technical documents that they have submitted such as PhilGEPS registration, Bid Security and Omnibus Sworn Statement are lawful and valid based on the effectivity date of each document. The required amount of transactions for completed contracts are complied and surpassed. The Single Largest Completed Contract that they have presented was with DOH Central Office for the Procurement of Lipid Based Nutrient Supplement for Pregnant Women and Lactating/Postpartum Women amounting to Php. 161,263,935.00, Notice of Award, Notice to Proceed, Contract, Delivery Receipt, Sales Invoice and Collection Receipt were presented upon inspection. The post-qualification team found out that the specifications indicated in the bid document were all complied.

WHEREAS, with the foregoing and after due deliberation, the Bids and Awards Committee resolved to declare the bid of Philippine Nutrifooods Corporation as a **responsive bid**;

WHEREAS, the funds availability has been certified by the Budget Section on October 06, 2020;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee **RESOLVES**, as it is hereby **RESOLVED**:

- a) To declare **Philippine Nutrifoods Corporation** as the **Sole Eligible and Responsive Bidder** for the **SUPPLY AND DELIVERY OF NUTRIPACKS FOR THE SFP 10TH CYCLE IMPLEMENTATION IN BICOL REGION per IB GOP 2020-DSWD-45**;
- b) To recommend the Award of the Contract to **Philippine Nutrifoods Corporation** in the amount of **FIFTY-FOUR MILLION SIX HUNDRED NINETY-SIX THOUSAND TWO HUNDRED FORTY PESOS (P 54,696,240.00)**;
