INVITATION FOR NEGOTIATED PROCUREMENT

BOARD AND LODGING FOR THE CONDUCT OF MAKILAHOK: STRENGTHENING PARTICIPATORY GOVERNANCE IN BARANGAY DEVELOPMENT PLANNING IN ALBAY

In view of the two (2) failed public biddings conducted, the Department of Social Welfare and Development, Field Office V, intends to negotiate, as authorized by its Regional Director, per BAC Resolution No. KC-2019-09-007 dated September 9, 2019, in accordance with Section 53.1 Two Failed Biddings of the Revised IRR of RA 9184 the total sum of One Million Six Hundred Fifty Four Thousand Four Hundred Pesos (P1,654,400.00) being the Approved Budget for the Contract (ABC) to payments under the contract for IB No. GOP/19-DSWD_KC-26. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Department of Social Welfare and Development, Field Office V now invites offers/proposals for the said project. Delivery of the Goods is required per approved final schedule. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise

known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

A Request for Quotation/canvass may be acquired by interested Bidders starting September 13, 2019 from the address below. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.

The Department of Social Welfare and Development, FO V will hold a Pre-Negotiation Conference September 16, 2019 at 1:30 P.M. at Procurement & BAC Secretariat Office, which shall be open to prospective bidders.

Offers/Proposal must be duly received by the BAC Secretariat at the address below on or before 1:00 P.M., September 19, 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Opening of offers/proposals shall be on September 19, 2019, 1:30 P.M. at DSWD Procurement & BAC Secretariat Office. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Department of Social Welfare and Development, FO V reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
