BAC RESOLUTION No. 2019-06-022

A RESOLUTION RECOMMENDING TO THE REGIONAL DIRECTOR TO DECLARE A FAILURE OF BIDDING IN THE FURNISH OF LABOR AND MATERIALS FOR THE PRODUCTION OF LISTAHANAN STICKERS TO BE USED FOR THE LISTAHANAN 3 NATIONAL HOUSEHOLD ASSESSMENT

WHEREAS, the PPD – (NHTU) Listahanan Program requested for the labor and materials for the production of Listahanan stickers to be used for the Listahanan 3 National Household Assessment with an Approved Budget Ceiling amounting to Php9,608,312.00 per IB No. GOP/19-DSWD-23;

WHEREAS, during the pre-bid conference on June 17, 2019 at 1:30PM, three (3) bidders participated namely: (1) AMS Printing Press, Inc., (2) Topbest Printing Corp. and (3) Anglowealth Ent. On the said activity, the checklist of requirements was discussed and several agreements were also reached. Said agreements were posted on PhilGEPS website as a bid bulletin for information and reference of all concerned bidders;


WHEREAS, a memo was received by the end user from the Central Office regarding the revisions in the requirements. A meeting was set with the end-user on June 21, 2019 to finalize the information to be indicated in a supplemental bid bulletin. During which, the end-user manifested their intention to make significant changes in the procurement requirement including but not limited to the technical specifications. Amendment however is substantially significant that a new invitation is deemed preferable. It was surmised that the conditions have significantly changed so as to render the project no longer technically feasible. Thus, to be fair to all parties and to correct any error committed, DSWD FO V opt to declare a **"FAILURE OF BIDDING"**, per Section 41 of the Revised IRR of RA 9184. A new invitation will be posted for the re-bidding of the above-mentioned project;

WHEREAS, three bidders have already paid for the amount of bidding documents of the said project. The bidders may use the paid amount to participate in the next procurement project. Should they opt not to participate in the said activity, the bidder may request for refund of the bid document fee amounting to **Php10,000.00**;


WHEREFORE, the Bids and Awards Committee **RESOLVES**, as it is hereby **RESOLVED**, to recommend to the Regional Director of DSWD Field Office V, Legazpi City, to declare a failure of bidding in the furnish of labor and materials for the production of Listahanan stickers to be used for the Listahanan 3 National Household Assessment due to the above-stated reason;


