2. The Department of Social Welfare and Development, Field Office V now invites bids for the Labor and Materials for various repair works, improvements and rehabilitation at DSWD FO V Centers – Lot 1. Completion of the Works is required is 120 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Department of Social Welfare and Development, Field Office V and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM.

5. A complete set of Bidding Documents may be acquired by interested bidders on November 11, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, in the amount of: Lot 1: P 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement

System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Social Welfare and Development, Field Office V will hold a Pre-Bid Conference on November 19, 2019, 10:30AM at DSWD FO V, Procurement Office which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 10:30AM, December 3, 2019. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 10:30AM, December 3, 2019 at DSWD FO V, Procurement Office. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Department of Social Welfare and Development, Field Office V reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
