Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as the</u> <u>Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form</u> <u>part of the Contract.</u>

In consideration for the sum of ONE MILLION SIXTY TWO THOUSAND SIX HUNDRED SEVENTY SEVEN PESOS AND ONE CENTAVO (P1,062,677.01) or such other sums as may be ascertained, ORLINK COMPUTER SALES AND SERVICES, agrees to provide, PROCUREMENT OF ICT EQUIPMENT & PERIPHERALS FOR DSWD FO V, in accordance with his/her/its Bid;

4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE V** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
