This Supplemental/Bid Bulletin is issued to all prospective bidders announcing the following:

Section II. Instructions to Bidders No. 5.3 a. For the procurement of Sterilized Milk: The Bidder must have completed a single contract that is similar to this Project, equivalent to <u>at least fifty percent (25%)</u> of the ABC.	Section II. Instructions to Bidders No. 5.3 a. For the procurement of Sterilized Milk: The Bidder must have completed a single contract that is similar to this Project, equivalent to <u>at least twenty-five percent (25%)</u> of the ABC.
Section VII. Technical Specifications Mode of Delivery: Milk supplies must be transported using a <u>refrigerated van/truck, maintaining 4 degrees Celsius</u> to preserve the quality of milk. The sterilized milk should be packed with at least 30 pieces per box. Boxes must be carefully stacked in crates. During transport and delivery, milk boxes should not be placed in or exposed to direct sunlight.	Section VII. Technical Specifications Mode of Delivery: Milk supplies must be transported using a <u>closed, clean van or truck</u> equipped to maintain a <u>temperature of 24°C</u> to preserve milk quality. The sterilized milk should be securely packed in boxes, with <u>at least 30 pieces per box</u> . These boxes must then be carefully <u>stacked in crates</u> to ensure stability and protection during transit. Throughout transport and delivery, milk boxes <u>must not be placed in or exposed to direct sunlight</u> to maintain product integrity.
Packaging: The bidder inquired whether it is acceptable to use generalized retort pouches for the milk supplies, provided that each pouch is labeled "Not for Sale", and that only the outer box bears the "DSWD MFP" marking.	Packaging: The use of generalized retort pouches is acceptable, provided that each pouch is clearly labeled with "Not for Sale" and the outer box is properly marked with "DSWD MFP". This ensures compliance with distribution and branding requirements.
Submission of the Bidding Documents:	Bidders may also submit their bidding documents <u>via courier</u> , provided that the Procuring Entity <u>receives the documents on or before the deadline</u> .
